

## INTRODUCTION

### Joint and several liability

In the fight against social dumping and social fraud the mechanism of joint and several liability is one of the key issues both on a European and on a national level.

Is this mechanism the new panacea in the fight against social fraud or is it a sledgehammer to crack a nut? Should it be considered as a big stick for enforcement and inspection services – and therefore as an ultimum remedium sensu stricto – or on the contrary as the mother of all enforcement measures? Does it only aim at mala fide players on the market or should the bona fide entrepreneurs fear it as well? And finally, will the joint and several liability mechanism nip mala fide practices in the bud or will it be a vain attempt?

Iris is organising an evening seminar on joint and several liability in all its aspects from a national and European perspective: (subsidiary) joint and several liability, chain versus direct liability, the transposition of the Sanctions Directive into Belgian Law and joint and several liability as included in the proposal for a European Enforcement Directive.

The Minister for Employment, Ms De Coninck, represented by her advisor Mr Ludo Beck, and State Secretary for the Fight against Social and Tax Fraud, Mr John Crombez elucidate their policies, the European Commission covers a number of (proposals for) new directives, the inspection services talk about the legislation in practice and the social partners debate these subjects.

Afterwards, at a rich reception, participants will have ample opportunity to exchange views with the speakers.
